I received yesterday, three of my letters back from you mother. All enveloppes were marked "Refused." What good can come of such painful provocation ?

I also have heard nothing from you, confirming my belief that everyone in this family is as crazy as the other.

A few days ago, I learned of your mother's serious illness. I was and remain devastated -- she needs me, and I need to be with her. Still, my attorney's calls to your own, or Amon -- whomever 's that is (I am purposely staying as far away from all these things as I can), was received by an aggressive and provocative response. As a result, a rapid end is prevented by more senseless if meritorious litigation. Imagine denying the DJG Regency Properties LP (I hope structured as I suggested it in an earlier settlement proposal !!!) Silly, as the whole thing will quickly come undone.

Provocation, aggression, a communication breakdown : all prescriptions for everything that ails each and every one of else. How to make any of you understand?


