My dear Donna,

Things are simply going to get worse.

Unthinking lawyers will sink you still deeper.

David raised a counter claim in his defenses for the \$14,900 provided to be paid to him under the "existing settlement" agreement.

Firstly this amount is not due to him, because the conditions set forth in the "existing agreement" have not been satisfied. Secondly, his answer refers to the provision of the "settlement agreement" between us.

Because David discloses the existence of the "existing agreement" and because David is clearly privy to its content... You have defaulted still again. David could only have gotten a copy of the agreement, which he supplied to his lawyers from you or your agent. The "existing agreement" strickly prohibits disclosure by either of us of the "existing agreement", and prohibits any copies save for the two we have. Gold and Kaplan were to destroy their sets, but regardless, the agreement was to remain strickly confidential. You have defaulted by providing a third party with a copy and or its content !

I had been hesitating suing to enforce the "existing agreement", because I preffered to keep it confidential. confident in the fact that we would eventually fashion a peace that we could BOTH live with. As you have made the document public by including it in David's lawsuits, I am immediatly instructing Noel Kaplan, by copy of this fax, to commence enforcement of the agreement... I note, that you have purposefully failed to transfer all non-US accounts, that you have at least to date failed to provide me with \$2,000,000 + in cash, as clearly required by the "existing agreement", and that you have and continue to fail to pay the interest due me, the first installment of which was due on January 1.

This breach of confidentiality is serious.

Things keep getting worse for you. The Frist Fidelity lawsuit makes my case for damages against you. I will pursue that claim this coming week.

My dearly beloved Donna:

WHATEVER THE APPEARANCES, nothing has changed my original comments and objectives.

The clear problem of course, is your obstinance... your lack of flexibility and your decisiveness that any kind of compromise on the issue of reconciliation would be surrender or defeat. Of course, full reconciliation would be the greatest victory you could achieve, because you would have won all the corrections and changes you needed and/or desired !

Whatever, communication will get us out of this impass as certainly as the lack of it got us in this deep. There is nothing worse than a lack of communication.

I do get it Donna, but contrary to yourself, I do not accept things... disastrous things... without some attempt at avoiding their occurrence and their consequences.

Surely, if we cannot make some progress, this may end in consensual divorce (there will never be a contested divorce) and a continuation of this separation will not proceed much beyond the end of April unless we come to some agreement for peace. The terms for a consensual divorce are outline in my fax to Gold of this morning, a copy of which I am transmitting here.

I am also transmitting a copy of my fax to Alicia.

I am holding on to the premise, that whatever the stumbling block (the hurdles of life !), we can overcome it. I want you only good, but I will not accept a "solution" where I only lose-lose... that is what you are offering.

I think with a little more work on both our parts, we can find a meeting point.

That point however, cannot ever exclude me from your life.

Face that, accept it, and things will go much better.

The only viable goal for us is a lasting peace.
